- 1. You must be a BAC Local 4 member in good standing.
- 2. Fill out the OSHA enrollment form completely. Forms can be found on our apprenticeship website: https://www.bac4ca.org/tile-layer-tilemarble-finisher-terrazzo-apprentice-program
- 3. You must provide an accurate and working email address.
- 4. Enrollment forms should be sent to the apprenticeship office at perla-jac@sbcglobal.net for Tile Layers and Tile, Marble and Terrazzo Finishers.
- 5. The Apprenticeship office will send you an email confirmation. Please check your spam folder. You must respond to the email to confirm you have a valid email address.
- 6. After your email is confirmed; you will receive an email with instructions and links to training websites.
- 7. After completion send your Certificate of Completion and payment receipt to the Apprenticeship Office. You must do this to receive reimbursement.
- 8. After your Certificate and receipt is received by the Apprenticeship office. Your completion will be documented with the Apprenticeship office.
- 9. Proof of completion will then be sent to the Union Hall.
- 10. The Labor Management Cooperation Committee will reimburse Members up to \$79.00 upon presentation of a valid OSHA 10 card and acceptable receipt for payment.
